**Multi-Family Properties** – Upgrading to energy efficient equipment in multi-family properties can result in lower energy and maintenance costs while improving tenants’ satisfaction. In addition to replacing equipment and systems in common areas, multi-family properties with master electric meters are eligible for incentives to replace appliances and equipment. If a resident is interested, Quick Home Energy Check-up are available as well.
